

**Washington Uniform Law Commission (WULC)**

**1. Call to Order/Attendance**

DC continues to serve on the Parliamentary Practice Committee.

AR continues to serve on a couple of Standing committees and plans to be more active in the new year.

MA continues to be supportive of the continued work of the committee and has no formal committee assignments at this time.

KBX serves as ABA Advisor on the Restrictive Covenants in Deeds Committee.

Chair MR serves on the Recurring Service Charges Drafting Committee. She also serves on the U.N. Convention on International Settlement Agreements Resulting from Mediation (Singapore Convention) Study Committee and the Election Law Study Committee.
