

**Washington Uniform Law Commission (WULC)**  
**Meeting Minutes**  
**May 3, 2023**

This meeting was coordinated by the Code Reviser's Office (CRO), 415 15<sup>th</sup> Ave. SW, Olympia, WA, 98504, as a Zoom conference.

**1. Call to Order/Attendance**

Chair Michele Radosevich (MR) called the meeting to order at 4:05 PM.

**2. Approval of Minutes of February 8, 2023, Meeting**

DC made a motion, seconded by KB, to approve the minutes of the February 8, 2023, meeting. All in attendance voted to approve and the minutes were adopted.

**3. Fiscal Report**

**4. Legislative Report**

The following are the acts worked on during the 2023 legislative session:

HB 1088 (the Uniform Family Law Arbitration Act).

HB 1121 (the Uniform Child Abduction Prevention Act).

HB 1165 (the Uniform Civil Remedies for the Unauthorized Disclosure of Intimate Images Act).

SB 5005 (the Uniform Partition of Heirs Property Act and the Uniform Easement Relocation Act).

SSB 5077 (the Uniform Commercial Code and Emerging Technologies).

SB 5481 (the Uniform Telehealth Act).

JP updated the committee that four out of six bills have already passed and SSB 5077 will be signed by the Governor. HB 1121 did not pass this year but most likely be back next year and SB 5481 is also on hold for now.

## **5. Commissioner Activities**

KB is monitoring committee travel.

DC is focusing on his work with the Committee on Parliamentary Practice and is setting up meeting via zoom to review roles and standards. Other committee chairs will be invited to attend the zoom meeting as well.

KBX is working on Commercial Loan Disclosure Study Committee for lending disclosures.

MA is looking forward to and preparing for the annual conference trip.

JP will be in Chicago next weekend for the Legislative Council meeting. He is also chairing the committee of the whole for consideration of the Determination of Death Act at the annual meeting.

MR shared that the Recurring Service Charges Drafting Committee she was a part of has been disbanded. She is a part the Election Law Study Committee and still involved in the Singapore Convention on Mediation Committee. She has recently been asked to be Division Chair this coming year.
