# Washington Uniform Law Commission (WULC) Meeting Minutes May 9, 2018

This meeting was coordinated by the Code Reviser's Office, 415 15<sup>th</sup> Ave SW, Olympia, WA, 98504, as a telephone conference.

#### 1. Call to Order 4:00 PM/Attendance

Chair Dennis Cooper called the meeting to order at 4:05 PM.

Chair Dennis Cooper (DC) and Commissioners Anita Ramasastry (AR), Marlin Appelwick (MA), Michele Radosevich (MR), Jamie Pedersen (JP), and Kyle Thiessen (KT) attended the meeting.

Kathy Buchli (KB, Code Reviser Designate) and Jessica Braatz (JB) also attended the meeting.

## 2. Approval of Minutes of February 14, 2018 Meeting

MR made a motion, seconded by MA, to approve the minutes for the February 14, 2018, meeting. All in attendance voted to approve.

# 3. Report of National ULC President

DC gave a recap of AR's appointment as NULC president. AR discussed various acts and who will be working on them. MA and JP each agreed to chair a session of the committee of the whole, MA to cover Highly Automated Vehicles (Driverless Cars) and JP to cover Electronic Wills.

## 4. Legislative Report

JP provided a recap of the three measures that passed in 2018 (SSB 6175, ESSB 5990, and ESSB 6037). A discussion ensued on measures being worked on for legislation in 2019, including the Revised Uniform Unclaimed Property Act, Unsworn Declarations Act, Limited Cooperative Association, and Guardianship, Conservatorship, and Other Protective Arrangements Act. MA provided details on the progress being made with Recognition and Enforcement of Canadian Domestic Violence Protection Orders.

JP and MA provided input for updates to the website, including effective dates, chapter numbers, and pending legislation.

A discussion followed regarding effective dates of the Parentage Act, Uniform Common Interest Ownership Act, and Emergency Volunteer Healthcare Practitioners.

#### 5. Financial Report

JB provided an overview of the commission's current financial status. A discussion followed regarding yearly dues, upcoming budget requests, and carry-forward levels.

#### 6. Other Business

The commissioners discussed their plans for the upcoming NULC conference in July. All commissioners plan to attend the conference. DC is putting together the delegation dinner, and a

discussion took place regarding possible dates. KT mentioned that he will drop in for a few days, but that KB would be the commissioner to attend the conference from the Code Reviser's Office.
